Chris Rauen: Sent an email out to all of the board members, Chris is working with Katie Simmons through the URCC trying to develop long term funding for MCP.

John Stonebreaker: Has great knowledge of the supervisors board and how to approach the board for long term funding for MCP just as they did for Honey Run Covered Bridge. He explained the how and why the county can find the funds through the sums the county received from the Camp Fire settlement.

Executive Director' Report: Executive Director's Report -

Snowstorm – Center was dark for a few days, snow plows on parking lot, coordinated to help get people plowed out.

Community Resource Hubs call with North Valley – There is a movement in the county, with North Valley leading it, to get all community resource centers, safe spaces, community centers, resource centers, collaborating together. This was more of a general discussion with some discussion about funding.

There will be two add'l community centers in Magalia within the next five years: *Lakeridge Apartments – 3800 sq ft clubhouse *Lakeridge Park – Large recreation building

Part II: Report from NVCF Non-Profit Collaborative Leadership Intensive Jan 9-13 – Fundraising and Sustainability – think about MCP

*Fundraising was biggest topic, and how to approach your donors, with an emphasis on individual donors and including them in your events, continually hitting them up for money, don't be afraid to ask...but you have to make a good case to them. It can be hard to ask people for money, but if it's your survival you've got to do it.

*Strategic Plan – a plan that shows fiscal sustainability. How are you showing that you can pay your rent and operating expenses, where is that funding coming from. If your revenue sheet is blank or only half accounted for, how do you explain the rest. North Valley is looking for this from us.

*"No non-profit with a solid mission and reason for existing should ever close their doors." You change, evolve or even merge with another larger organization

that closely matches your mission that has the funding mechanism, but you shouldn't close.
